***Editor's note**—Printed herein is the Land Development Ordinance, Ord. No. 03-007, adopted May 22, 2003, effective July 1, 2003. This Ordinance completely replaces the Unified Development Ordinance. For the ordinance history of the UDO, see the Land Development Ordinance Disposition Table—1976 Code.

This publication has been altered as little as possible from the original Land Development Ordinance. Obvious misspellings and punctuation errors have been corrected, and where necessary, material added for clarification has been placed in brackets. Amendments to the LDO are indicated by parenthetical history notes following amended provisions.
