Your Committee on License and Consumer Protection, having under consideration an ordinance introduced by Alderman George Cárdenas (which was referred on February 28, 2018), to amend the Municipal Code of Chicago by lifting subsections 4-60-023 (12.280) and 4-60-023 (12.281) to allow the issuance of additional package goods licenses on portions of South Archer Avenue, begs leave to recommend that Your Honorable Body *Pass* the ordinance which is transmitted herewith.

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Section 4-60-023 of the Municipal Code of Chicago is hereby amended by deleting the language struck through, as follows:

4-60-023 Restrictions On Additional Licenses.

Subject to the provisions of subsection 4-60-021(c), no additional package goods license shall be issued for any premises located within the following areas:

~~(12.280) On both sides of Archer Avenue, from 40th Place to 42nd Street.~~

~~(12.281) On both sides of Archer Avenue, from California Avenue to Richmond Street; and on the north side of Archer Avenue, from Richmond Street to Sacramento Avenue.~~

SECTION 2. This ordinance shall be in force and effect upon passage and publication.
