**ORDINANCE NO. 10678 (NEW SERIES)**

**ORDINANCE AMENDING SECTION 72.169.17., 72.169.22.5., & 72.172.36. OF THE  
SAN DIEGO COUNTY CODE RELATING TO SPEED LIMITS ON COUNTY  
MAINTAINED ROADS IN SAN DIEGO COUNTY**

The Board of Supervisors of the County of San Diego ordains as follows:

Section 72.169.17. of the San Diego County Code is amended to read as follows:

Section 72.169.17. EL CAJON. The prima facie speed limit on Greenfield Drive from the westerly limits of the City of El Cajon near Pioneer Way (City Street) easterly to the El Cajon City Limit near Victor Street (City Street) is hereby decreased to and established at 35 miles per hour.

Section 72.169.22.5. of the San Diego County Code is amended to read as follows:

Section 72.169.22.5. RANCHO SAN DIEGO. The prima facie speed limit on Wieghorst Way from the east line of Fury Lane easterly to the west line of Calle Albara is hereby decreased to and established at 45 miles per hour.

Section 72.172.36. of the San Diego County Code is amended to read as follows:

Section 72.172.36. MOUNT HELIX. The prima facie speed limit on Mount Helix Drive from the east line of Mount Helix Drive at the intersection of Vivera Drive westerly to the south line of Mount Helix Drive at the intersection of Vivera Drive is hereby decreased to and established at 20 miles per hour.


