**ORDINANCE AMENDING SECTIONS 72.161.35., 72.161.35.4, 72.169.74.7., 72.175.1.,
DELETING SECTION 72.169.4., AND ADDING SECTION
72.169.74.14. OF THE SAN DIEGO COUNTY CODE RELATING TO SPEED LIMITS
ON COUNTY MAINTAINED ROADS IN SAN DIEGO COUNTY**

The Board of Supervisors of the County of San Diego ordains as follows:

Section 72.161.35. of the San Diego County Code is amended to read as follows:

Section 72.161.35. VALLEY CENTER. The prima facie speed limit on Valley Center Road from the north line of Ridge Ranch Road to the west line of Cole Grade Road is hereby decreased to and established at 45 miles per hour.

Section 72.161.35.4. of the San Diego County Code is amended to read as follows:

Section 72.161.35.4. VALLEY CENTER. The prima facie speed limit on Valley Center Road from the Escondido City Limit (north of Lake Wohlford Road) northerly to the south line of Ridge Ranch Road is hereby decreased to and established at 60 miles per hour.

Section 72.169.74.7. of the San Diego County Code is amended to read as follows:

Section 72.169.74.7. BONSALL. The prima facie speed limit on Camino Del Rey from the east line of State Route 76 easterly to the west line of Via Maria Elena is hereby decreased to and established at 45 miles per hour.

Section 72.175.1. of the San Diego County Code is amended to read as follows:

Section 72.175.1. LAKESIDE. The prima facie speed limit on Julian Avenue from

Section 72.169.4.


Section 72.169.74.14. of the San Diego County Code is added to read as follows:
