

ORDINANCE NO. 9952 (N.S.)

AN ORDINANCE AMENDING SECTION 362 AND 364.2 OF ARTICLE XX
OF THE SAN DIEGO COUNTY ADMINISTRATIVE CODE RELATING TO
COUNTY COUNSEL HOURLY BILLING RATES

The Board of Supervisors of the County of San Diego ordains as follows:

Section 1. The amendments made by this ordinance are intended to update the Department of Planning and Land Use and Department of Public Works fee ordinances to implement County Counsel hourly billing rates, which will allow for full-cost recovery in accordance with Board Policy B-29. These rates were approved by the Board of Supervisors on June 17, 2008. No other revisions are being made.

Section 2. Section 1 of Schedule B - Provisions of Section 362 of Article XX of the San Diego County Administrative Code is hereby amended to read as follows:

1. STANDARD BILLING RATES/TIME AND MATERIAL RATES:

Unless otherwise specified in this section, all fees and deposits and time and material charges shall be calculated and will be charged using the following standard hourly billing rates:
